Proposed scale of charges

Note: Written warnings actually to educate not to be too harsh. All members to get emailed a copy of the code of ethics & model rules & incorporation rules.

- (A) **TO CONDUCT MYSELF AT ALL TIMES WITH COURTESY TOWARDS OTHERS AND IN A MANNER THAT WILL REFLECT CREDIT ON MY BREED. TO CO-OPERATE WITH AND TO PARTICIPATE IN ASSISTING THE CLUB TO PROTECT THE ROTTWEILER BREED.**

CHARGE: 2 written warnings then 1 month suspension or 3 months if severe.

AS A BREEDER I SHALL:

- (B) **BITCHES SHALL NOT BE BREED WITH BEFORE THEY REACH THE AGE OF 22 (TWENTY-TWO) MONTHS OF AGE. BITCHES MUST BE 24 (TWENTY-FOUR) MONTHS OF AGE BEFORE THEY WHELP. A BITCH SHALL NOT BE BREED FROM MORE THAN TWICE IN ANY SUCCESSIVE 12 (TWELVE) MONTH PERIOD. IN AN EVENT THAT A BITCH IS BRED TWICE IN A 12 (TWELVE) MONTH PERIOD, THEN IN NO CIRCUMSTANCES WILL THE BITCH BE BREED FROM FOR A PERIOD OF 12 (TWELVE) MONTHS AFTER THE SECOND LITTER. NOT TO MATE ANY BITCH AFTER SHE TURNS 8 YEARS OF AGE.**

CHARGE: 1 year loss of membership

- (C) **I WILL NOT BREED MY REGISTERED BITCH TO ANY UNREGISTERED DOG, OR DOG ON A LIMITED REGISTER, OR TO ANOTHER BREED.**

CHARGE: 1 year loss of membership

- (D) NOT TO SELL DIRECTLY OR INDIRECTLY TO ANY COMMERCIAL, WHOLESALE OR RETAIL PET DETAILERS, NOR SHALL I KNOWINGLY PERMIT A DOG TO BE ADVERTISED, DISPLAYED OR SOLD ON COMMISSION BY A COMMERCIAL DOG WHOLESALER, RETAIL PET DEALER OR AS AUCTIONEER. TO ENSURE THAT ALL PUPPIES ARE SOCIALISED, WOTMED, VACCINATED AND AT LEAST 8 (EIGHT) WEEKS OF AGE BEFORE SALE. TO ENSURE THAT ALL PURCHASERS CLEARLY UNDERSTAND THEIR RESPONSIBILITY FOR THE CARE AND WELFARE OF THE BREED AND ARE SUPPLIED WITH INSTRUCTIONS ON HOW TO BRING UP A WELL ADJUSTED ROTTWEILER INCLUDING IMMUNISATION CERTIFICATES, DIETARY INFORMATION AND A COPY OF THIS CODE OF ETHICS. I WILL NOT ALLOW ANY PUPPY TO LEAVE MY PREMISES UNLESS IT HAS BEEN TATTOOED OR MICROCHIPPED IN ACCORDANCE WITH THE NATIONAL ROTTWEILER COUNCIL (AUSTRALIA) SCHEME.**

CHARGE: 1 written warning, 2nd offence 1 month suspension

- (E) NOT KNOWINGLY MISREPRESENT THE CHARACTERISTICS OF THE ROTTWEILER.**

CHARGE: Written warning & fine of \$100

- (F) ABIDE BY THE NATIONAL ROTTWEILER COUNCIL CURRENT HIP DYSPLASIA SCHEME AND ELBOW SCHEME (THE NRCA MAY MAKE CHANGES TO THE CURRENT HD SCHEME/ ELBOW SCHEME OR ADOPT ANY NEW HD SCHEME/ ELBOW SCHEME WITH THE APPROVAL OF MEMBER CLUBS) EYE AND MOUTH CERTIFICATES MUST BE OBTAINED, IN ACCORDANCE WITH THE NRCA POLICY.**

CHARGE: 3 month suspension 2 offence 6 months

- (G) I WILL ONLY BREED FOR THE PURPOSE OF PRODUCING SOUND HEALTHY PUPPIES OF CORRECT CHARACTER AND WITH THE INTENTION OF IMPROVING THE ROTTWEILER BREED AND ONLY IF I HAVE THE TIME AND RESOURCES TO ADEQUATELY CARE FOR A LITTER.**

CHARGE: Written warning

AS I A STUD DOG OWNER I SHALL:

(A) I WILL ONLY BREED WITH DOGS NOT YOUNGER THAN 12 (TWELVE) MONTHS OLD, THAT MEETS WITH THE FCI STANDARD AND COMPLIES WITH THE NRCA REQUIREMENTS. I WILL NOT BREED HIM TO A BITCH OF LESS THAN 22(TWENTY-TWO) MONTHS OF AGE AT THE DATE OF THE MATING.

CHARGE: 3 months loss of membership

(D) SHOULD A BITCH FAIL TO CONCEIVE AFTER BEING BRED TO A STUD DOG, A REPEAT SERVICE SHALL BE OFFERED TO THE SAME BITCH IN THE FOLLOWING 12(TWELVE) MONTHS, PROVIDED THAT THE ORIGINAL STUD DOG IS STILL AVAILABLE AND IN GOOD HEALTH, AND AT SUCH TIME AND PLACE AS IS MUTUALLY AGREED TO BY THE OWNERS OF THE STUD DOG AND THE BITCH.

CHARGE: Written warning 2nd offence 3 months suspension.

(E) I WILL PROVIDE THE OFFICIAL EVUATION RESULTS AS PER NRCA REQUIREMENTS AND A 3(THREE) GENERATION PEDIGREE TO THE BITCH OWNER.

CHARGE: Written warning

(F) I WILL NOT PERMIT MY DOG TO BE MATED TO ANY UNREGISTERED BITCH, A BITCH OF A DIFFERENT BREED, OR A BITCH ON A LIMITED REGISTER.

CHARGE: 1 year suspension

(H) I SHALL VIEW AND RETAIN COPIES FOR OFFICIAL RECORDS, HIP/ELBOW/EYE AND MOUTH CERTIFICATES AND PEDIGREE OF THE BITCH PRIOR TO MATING WITH MY STUD DOG, SO AS TO ENSURE THAT THE BITCH DOES MEET THE GUIDELINES SET BY THE NRCA FOR INHERETED DISEASES AND THAT SHE HAS NONE OF THE DISQUALIFYING FAULTS AS LISTED IN THE FCI STANDARD FOR THE ROTTWEILER BREED. I SHALL ALSO VIEW THE REGISTRATION PAPERS OF THE BITCH TO ENSURE THE PERSON PRESENTING THE BITCH IS THE REGISTERED OWNER OF THE SAID BITCH.

CHARGE: 3 months suspension 2nd offence 6 month suspension.
