EXPLANATIONS:

ROTTWEILERS OWNED:

It is not a prerequisite that applicants own a Rottweiler, or that Rottweilers owned are pedigreed and registered. However, where applicants own pedigreed Rottweilers, copies of their pedigrees must be forwarded with this application

MEMBERSHIP:

Dual Membership consists of two members of the one family, residing at the same address or any two persons who are partners in the conduct of a Kennel Prefix in their joint names registered with the ANKC. Both persons must be 16 years or older. Each person is entitled to one vote each. Both persons must sign the application form.

Single Membership covers one person, 16 years or older. Said individual being entitled to one vote.

Junior Membership covers one person less than 16 years of age. Said individual is not entitled to vote or hold office.

(Please Note – To be eligible for RCQ Inc. Litter notices or RCQ Inc. awards for titles, all registered owners of the Rottweiler must be financial members of the RCQ Inc. for not less than 12 consecutive months.)

MEMBERSHIP YEAR:

The financial year of The Rottweiler Club of QLD Inc. starts as at 1st March each year. All membership renewals are due at this time, regardless of the time of application. Membership applications accepted after the Second Wednesday in November each year, shall include the following years membership and WILL NOT require renewal as at 01st March the following year.
